

Contract Agreement

THIS AGREEMENT is made the 1st day of the month of, June, 2022, between Mzuzu City Council of P.O. Box 1, Mzuzu (hereinafter called "the Employer"), of the one part, and SOS Construction of P.O. Box 20666, Mzuzu (hereinafter called "the Contractor"), of the other part:

WHEREAS the Employer is desirous that the Contractor execute Upgrading Of Sonda To Dunduzu M1 Road (Hereinafter called "the Works") and the Employer has accepted the Bid by the Contractor for the execution and completion of such Works and the remedying of any defects therein for the sum of MK5,856,857,874.98 (Five Billion Eight Hundred Fifty-Six Million Eight Hundred Fifty-Seven Thousand Eight Hundred Seventy-Four Kwacha Ninety-Eight Tambala only) (hereinafter called the Contract Price) within a periodcalendar days.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:
 - a) this Contract Agreement (if completed)
 - b) the Minutes of Contract Negotiations (if any)
 - c) the Letter of Acceptance
 - d) the Letter of Bid
 - e) the Special Conditions of Contract
 - f) the General Conditions of Contract
 - g) the Particular Specifications
 - h) the Standard Specifications (SATTCC 1998, reprinted 2001)
 - i) the Drawings and
 - j) the Priced Bill of Quantities
 - k) the Completed Qualification Information Forms and any other documents forming part of the contract.
3. In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the Works and remedy any defects therein in conformity in all respects with the provisions of the Contract.

4. The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects therein the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
5. The contract Price or such other sum as may be payable shall be paid in US dollars and Malawi Kwacha.
