AGREEMENT

THIS AGREEMENT made the 10th day of January, 2022, between GOVERNMENT OF THE REPUBLIC OF MALAWI acting through Ntcheu District Council of Private bag 1, Ntcheu (hereinafter called the "employer") of the one part, and FrightonMazinga carrying on business as Moss Construction of Post Office Box 31284, Lilongwe (hereinafter called "the contractor"), of the other part (collectively referred to as "Parties").

WHEREAS the Employer is desirous that the Contractor carries out Construction of Manjawira Staff
House at Manjawira Health Center in Ntcheu District (hereinafter called "the works") and the
Employer has accepted the Bid by the Contractor for the execution and completion of such Works and the
remedying of any defects therein for the sum of MK 39,193,241.23(Thirty Nine Million One
Ninety Three Thousand Two Hundred Forty -One Malawi Kwacha Twenty Three Tambala) (hereinafter
called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Contract referred to.
- 2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) the General Conditions of Contract;
 - (b) the Special Conditions of Contract;
 - (c) the Schedule of Requirements;
 - (d) the Bid Submission Form and Price Activity Schedules or Priced Bill of Quantities submitted by the Contractor;
 - (e) the Employers Notification to the Contractor of award of Contract; and
 - (f) the Award Acceptance letter by the Contractor
 - 3. In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the Works and remedy any defect therein in conformity in all respects with the provisions of the Contract.
 - 4. The Employer hereby covenants to pay the Contractor in consideration of the provision of the Execution and completion of the Works and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
 - 5. The Contract Price or Such other sum as may be payable shall be paid in Malawi Kwacha.
