

## (a) AGREEMENT

THIS CONTRACT AGREEMENT is made on the \_\_\_\_\_ day of November, 2021

### BETWEEN

LILONGWE DISTRICT COUNCIL, acting on behalf of the Government of Malawi, and having its principal place of business at P.O. Box 93, Lilongwe, Malawi (hereinafter called "the Employer"),

### AND

PABET CONSTRUCTION incorporated under the laws of Malawi and having its principal place of business at P.O. Box 30862, Lilongwe, Malawi (hereinafter called "the Contractor").

WHEREAS the Employer is desirous that the Contractor execute *Construction Of Classroom Blocks - In Various Traditional Authorities In Lilongwe District Under GESD - Lot I- Construction Of Chiputu Primary School - T/A Masumbankhunda* (hereinafter called "the Works") and the Employer has accepted the Bid by the Contractor for the execution and completion of such Works and the remedying of any defects therein for the sum of *MWK24,182,884.33 (Twenty-Four Million One Hundred Eighty Two Thousand Eight Hundred Eighty Four Kwacha Thirty three tambala only)* (hereinafter called the Contract Price).

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement,:


- (a) The Contract Agreement (if completed)

The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects therein the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.




