Contract Agreement

THIS AGREEMENT made the 6th day of January, 2022, between. **M'mbelwa District Council (P.O. Box 132, Mzimba)** (hereinafter "the Employer"), of the one part, and **COMPETENT ELECTRICAL and SOLAR CONTRACTORS of P.O. Box 444, Mzuzu** (hereinafter "the Contractor"), of the other part:

WHEREAS the Employer desires that the 4 -High Yield borehole drilling in Various places in **M'mbelwa District Council under GESD Funds should** be executed by the Contractor and has accepted the contract at a Contract sum of **MK 14,853,975.00 (Fourteen Million Eight Hundred Fifty-Three Thousand Nine Hundred Seventy-Five Malawi Kwacha Only)**: for the execution and completion of the drilling and civil works within Fourteen days from date of contract signing and the remedying of any defects therein,

The Employer and the Contractor agree as follows:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Contract documents referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement. This Agreement shall prevail over all other Contract documents.
 - (a) the Letter of Acceptance
 - (b) the Bid Document
 - (c) the Particular Conditions
 - (d) the General Conditions of Contract, including appendix;
 - (e) the Specification
 - (f) the Drawings
 - (g) Bill of Quantities;¹ and

(h) any other document **listed in the PCC** as forming part of the Contract;

3. In consideration of the payments to be made by the Employer to the Contractor as specified in this Agreement, the Contractor hereby covenants with the Employer to execute the supply and delivery to remedy defects therein in conformity in all respects with the provisions of the Contract.

Subject to Deductions noted in this contract, the client agrees to pay the following amounts for each stage of work completed

iii. Civil Works	30%	4,456,192.50

Total Contract Fee	100%	14,853,975.00

4. The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the Supply and Delivery the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
