Agreement

THIS AGREEMENT made the 29th day of November, 2022, between Chitipa District Council of P.O. Box 1, Chitipa (hereinafter called "the Employer"), of the one part, and Lingstone Construction of Private Bag 10, Karonga (hereinafter called "the Contractor"), of the other part:

WHEREAS the Employer is desirous that the Contractor execute Construction of Market Shade at Chitipa Boma. (hereinafter called "the Works") and the Employer has accepted the Bid by the Contractor for the execution and completion of such Works and the remedying of any defects therein 90 days for the total sum of K26,931,265.00 (Twenty six million nine hundred thirty one thousand two hundred sixty five kwacha only

(hereinafter called the Contract Price).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement, words and expressions shall have the same meanings as are respectively
 assigned to them in the Contract referred to.
- The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:
 - (a) the General Conditions of Contract;
 - (b) the Special Conditions of Contract;
 - (c) the Schedule of Requirements;
 - (d) the Bid Submission Form and the priced Activity Schedule or priced Bill of Quantities submitted by the Contractor;
 - (e) the Employer's Notification to the Contractor of award of contract; and
- In consideration of the payments to be made by the Employer to the Contractor as
 hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and
 complete the Works and remedy any defects therein in conformity in all respects with the
 provisions of the Contract.
