(a) AGREEMENT

THIS CONTRACT AGREEMENT is made on the 30th day of

BETWEEN

LILONGWE DISTRICT COUNCIL, acting on behalf of the Government of Malawi, and having its principal place of business at P.O. Box 93, Lilongwe, Malawi (hereinafter called "the Employer"),

AND

BWALO CIVILS incorporated under the laws of Walawi and having its principal place of business at P.O. Box 2497, Lilongwe, Malawi (hereinafter called "the Contractor").

WHEREAS the Employer is desirous that the Contractor execute Construction Of 30 Ton Concrete Deck Bridges - In Various Traditional Authorities In Lilongwe District Under GESD - Lot IV- Mbavi River Concrete Deck Foot Bridge - T/A Njewa (hereinafter called "the Works") and the Employer has accepted the Bid by the Contractor for the execution and completion of such Works and the remedying of any defects therein for the sum of MWK24,999,354.12 (Twenty-Four Million Nine Hundred Ninety Nine Thousand Three Hundred Fifty Four Kwacha Twelve Tambala) (hereinafter called the Contract Price).

- 3. In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the Works and remedy any defects therein in conformity in all respects with the provisions of the Contract.

The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects therein the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
