THIS AGREEMENT made the **6th** day of **June, 2024** between **DOWA DISTRICT COUNCIL of P/BAG 2 DOWA** (Hereinafter "the Employer"), of the one part, and **M & A RAHELI JOINT VENTURE of P.O BOX 2799, LILONGWE** (hereinafter "the Contractor"), of the other part:

 - (l) World Environment, Social, Health and Safety including SEA/HS Matrix
 - (m) Code of Conduct
 - (n) Labour Management Plan
 - (o) The Contractor's program for carrying out of the Works including Project Manager's instructions

- (p) Corrected Bid Submission Form and Error Declaration Document
(q) Environmental and Social Management Plan
(r) Any other document listed in the CC as forming part of the Contract

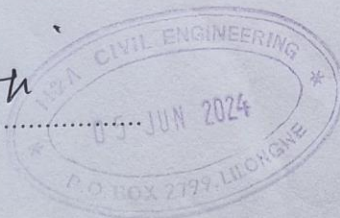
