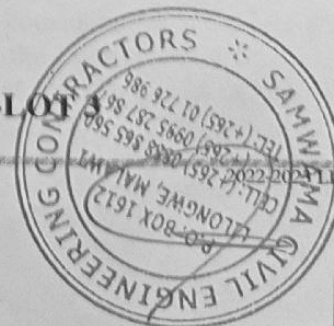

## a) Agreement

THIS AGREEMENT made the 10 day of Jan, 2023, between The Government of Republic of Malawi acting Through Lilongwe District Council of P.O Box 93 Lilongwe (hereinafter called "the Procuring Entity") of the one part, and Samwama Civil Engineering Contractors P.O. Box 1612, Lilongwe (hereinafter called "the Contractor"), of the other part:

### WHEREAS

*Livuwad*

the Procuring Entity invited bids for works and Related Services, viz., the Construction of ~~Kapangalika~~ River Deck Bridges in Traditional Authorities ~~Khongoni~~ in Lilongwe District and has accepted a Bid by the Contractor for the execution of those works at **Recommended Bid Price of MK67, 249, 332.10 (Sixty Seven Million- Two Hundred Forty Nine Thousand-Three Hundred Thirty Two Kwacha Ten Tambala Only ;** (hereinafter called "the Contract Price").

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:

- (a) the General Conditions of Contract;
- (b) **the Special Conditions of Contract;**
- (c) **the Schedule of Requirements;**
- (d) **the Bid Submission Form and the priced Activity Schedule or priced Bill of Quantities submitted by the Contractor;**
- (e) **the Employer's Notification to the Contractor of award of contract;**
- (f) **The Contractor's program for the carrying out of the Works including Architect's instruction;**
- (h) **Minutes of meetings and letters between the parties;**
- (i) **Annex 1 to Section 7 – World Bank's Fraud and Corruption Policy;**
- (j) **Annex 2 to Section 7 – World Bank's Environmental, Social, Health and Safety (ESHS) enhancements;**
- (k) **The ESHS Management Strategies and Implementation Plans;**
- (l) **Code of Conduct (ESHS);**
- (m) **Labour Management Plan;**
- (n) **Corrected Bid Submission Form and Error Declaration Document.**

3. In consideration of the payments to be made by the Procuring Entity to the Contractor as indicated in this Agreement, the Contractor hereby covenants with the Procuring Entity to execute the Works and Related Services and to remedy defects therein in conformity in all respects with the provisions of the Contract.

4. The Procuring Entity hereby covenants to pay the Contractor in consideration of the provision of the Works and Related Services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.



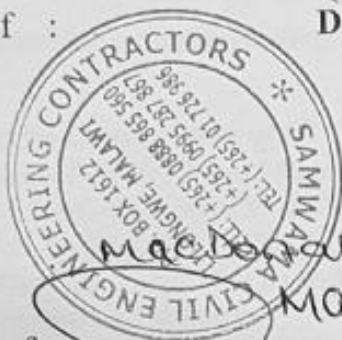
