This AGREEMENT is entered into between Karonga District Council whose address is P.O Box 35, KARONGA; (Hereinafter called "the Employer") and FIDELIS BUILDING CONTRACTORS whose address is P/O Box 330, Zomba; (Hereinafter called "the Contractor").

- 1.0. Project Title: Construction of Maternity wing at Mlare Health Centre in Karonga District.
- 2.0. Project Location: Mlare in Karonga Central Constituency.
- 3.0. Total Contract Price: K91,968,950.00, (Ninety One Million, Nine Hundred and Sixty Eight Thousand, Nine Hundred and Fifty Kwacha).
- 4.0. The contractor has been briefed regarding the quality of work required and shall execute the works in accordance with the drawings and specifications attached to this contract and remedy any defects therein in conformity in all respects with the provisions of the contract.
- 5.0. The contractor agrees to complete the works within a period of **One** hundred and ten (110) days with effect from the date of signing this contract.

10.0. The Employer has accepted the Bid by the Contractor for the execution and agrees to pay claims upon certification of the work executed invoicing the works for either by the following stages or calculated amount of works

6.0. The Contracting Authority shall retain from each payment due to the Contractor 5% as Retention Money until Completion of the whole of the Works, the amount retained Works. On Completion of the whole of the Works, the amount retained shall be repaid to the Contractor when the Defects Liability Period has shall be repaid to the Contractor when the Defects Liability Period has shall be repaid all defects have been corrected or remedied by the Contractor passed and all defects have been corrected or remedied by the Contractor passed and of the period.

7.0. The decision of the officer certifying quality of works as appointed by the Employer shall be final and conclusive. Therefore a works progress Certificate shall be issued by the Employer as required before any payment is made.

- This agreement may be terminated without obligation by Karonga District Council in any of the following circumstances:
 - When the agreement is fulfilled and accomplished as required herein; 8.1.
 - When the contractor fails to execute the works as required;
 - When both parties mutually agree to terminate the contract before completion due to special or unforeseen circumstances. 8.2. 8.3.
