#### **AGREEMENT**

THIS AGREEMENT made the day of Monday, 6<sup>th</sup> March, 2023, between Zomba City Council of Box 43, Zomba (hereinafter called "the Procuring Entity") the one part, and Wills Njoka Carrying on business as PROW Civils of P.O Box 1064 Lilongwe (hereinafter called "the Supplier"), of the other part:

WHEREAS the Procuring Entity invited bids for certain works and Related Services, viz., Construction of Flea Market Shops, and has accepted a Bid by the Contractor for the construction those works and Related Services in the sum of Mk 204,016,347.27 (hereinafter "the Contract Price").

#### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Contract referred to.
- 2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - a) the General Conditions of Contract;
  - b) the Special Conditions of Contract;
  - c) The Schedule of Requirements;
  - d) the Bid Submission Sheet and the Priced Bill of Quantities submitted by the Contractor;
  - e) the Procuring Entity's Notification to the Supplier of award of Contract; and
  - f) Negotiation Minutes
  - g) Letter of acceptance
- 3. In consideration of the payments to be made by the Procuring Entity to the Supplier as indicated in this Agreement, the Supplier hereby covenants with the Purchaser to provide the Goods and Related Services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 4. The Procuring Entity hereby covenants to pay the Supplier in consideration of the provision of the Goods and Related Services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
