## Agreement

THIS AGREEMENT made the 30<sup>th</sup> day of November, 2021 between Kasungu District Council of Private Bag 1, Kasungu (hereinafter called "the Procuring Entity"), of the one part, and of Kagolo Building Contractor of P.O. Box 136, Kasungu (hereinafter called "the Contractor"), of the other part:

WHEREAS the Procuring Entity is desirous that the Contractor <u>Construction of Malosa Teachers Development Centre (TDC) under GESD project (Labour only)</u> (hereinafter called "the Works") and the Procuring Entity has accepted the Bid by the Contractor for the execution and completion of such Works and the remedying of any defects therein for the sum of Six Million Four Hundred Twenty Five Thousand Three Hundred Seventy Five Kwacha Only (MK6,425,375.00) (hereinafter called the Contract Price).

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Contract referred to.
- 2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:
  - (a) the General Conditions of Contract;
  - (b) the Special Conditions of Contract;
  - (c) the Schedule of Requirements;
  - (d) the Bid Submission Form and the priced Activity Schedule or priced Bill of Quantities submitted by the Contractor;
  - (e) the Procuring Entity's Local Purchase Order and contractors acknowledgement of the order;
  - (f) Negotiation minutes
  - 3. In consideration of the payments to be made by the Procuring Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Procuring Entity to execute and complete the Works and remedy any defects therein in conformity in all respects with the provisions of the Contract.
- 4. The Procuring Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects therein the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
