THIS AGREEMENT is made on the 30th day of the month of, June, 2022, between Mzuzu City Council of P.O. Box 1, Mzuzu (hereinafter called "the Employer"), of the one part, and Hema Construction Ltd of P.O. Box 31200, Lilongwe (hereinafter called "the Contractor"), of the other part:

WHEREAS the Employer is desirous that the Contractor execute Upgrading of Choma Turn-Off to Dunduzu (M1) Road Block and Tafika Butchery to Nkhorongo Road To Bitumen Standard (Hereinafter called "the Works") and the Employer has accepted the Bid by the Contractor for the execution and completion of such Works and the remedying of any defects therein for the sum of MK3,035,607,394.50 (Three Billion Thirty-Five Million Six Hundred Seven Thousand Three Hundred Ninety-Four Kwacha Fifty Tambala only) (hereinafter called the Contract Price) within a period 1096 calendar days.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - the General Conditions of Contract
 - g) the Particular Specifications
 - h) the Standard Specifications (SATTCC 1998, reprinted 2001)
 - the Drawings and
 - the Priced Bill of Quantities
 - the Completed Qualification Information Forms and any other documents forming part of the contract.
- In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants 3. with the Employer to execute and complete the Works and remedy any defects therein in conformity in all respects with the provisions of the Contract.

- 4. The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects therein the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
- 5. The contract Price or such other sum as may be payable shall be paid in US dollars and Malawi Kwacha.
