This ADDENDUM No. 1 (hereinafter called the "Addendum") to the Contract (hereinafter called the "Contract") is made the _____ day of the month of _____ 2023, between, on the one hand, the Electricity Supply Corporation of Malawi Limited, having its principal place of business in ESCOM House, 9 Haile Selassie Road, P.O Box 20147 Blantyre, Malawi (hereinafter called the "Purchaser") and, on the other hand, Inhemeter Company Limited (hereinafter called the "Supplier").

WHEREAS

WHEREAS the Purchaser invited Bids for Supply and Delivery of Single Phase DIN Rail Split Prepaid Meters, 63A Single Phase MCBs, 2Way IPH Split Prepaid Meter Pole Top Enclosures, and Ready Boards (hereinafter referred to as "Goods") and Provision of Factory Acceptance Test (FAT) (hereinafter referred to as "Services") and has accepted a Bid by the Supplier for the supply of those Goods in the sum of **Two Million Two Hundred and Fifty-Six Thousand Dollars (USD2,256,000.00)**, (hereinafter called "the Contract Price"). The Contract Price excludes VAT and other taxes payable in the Purchaser's country.

The Purchaser and the Supplier now wish to amend certain terms of the Contract by modifying as follows:

1. **To increase quantities of three items** (Single Phase Meters Split Type, Single Phase MCBs and Two Way Meter Boxes)
2. **Amend delivery period**

Initial Contract Stipulation:

WHEREAS the Purchaser invited Bids for Supply and Delivery of Single Phase DIN Rail Split Prepaid Meters, 63A Single Phase MCBs, 2Way IPH Split Prepaid Meter Pole Top Enclosures, and Ready Boards (hereinafter referred to as "Goods") and Provision of Factory Acceptance Test (FAT) (hereinafter referred to as "Services") and has accepted a Bid by the Supplier for the supply of those Goods in the sum of **Two Million Two Hundred and Fifty-Six Thousand Dollars (USD2,256,000.00)**, (hereinafter called "the Contract Price"). The Contract Price excludes VAT and other taxes payable in the Purchaser's country.


