LILONGWE DISTRICT COUNCIL, acting on behalf of the Government of Malawi, and having its principal place of business at P.O. Box 93, Lilongwe, Malawi (hereinafter called "the Employer"),

## AND

BONONGWE BUILDING CONSTRUCTIONS incorporated under the laws of Malawi and having its principal place of business at P.O. Box 1416, Lilongwe, Malawi (hereinafter called "the Contractor").

WHEREAS the Employer is desirous that the Contractor execute Construction Of Office Blocks - In Various Traditional Authorities In Lilongwe District Under GESD - Lot I- Construction Of Office Block At Senior Chief Chiseka (hereinafter called "the Works") and the Employer has accepted the Bid by the Contractor for the execution and completion of such Works and the remedying of any defects therein for the sum of MWK25,500,000.00 (Twenty-Five Million Five Hundred Thousand Kwacha only), (hereinafter called the Contract Price).
